CIRCULAR

As also enunciated in circular vide D. No. 2692/Proc. Dated 20.08.2018, it has been observed that students stage Dharnas and organise Peace March/Candle March/ Public Meetings etc. without obtaining prior written permission of the undersigned, which disrupts the peaceful academic atmosphere in the University. In continuation to the same, the following is being reiterated:

- 1) Permission for any event being organised by bonafide students of the University has to be sought at least 48 hours in advance from the Office of the Proctor on prescribed proforma. This would facilitate us in examining the request in the right perspective.
- 2) AMU being a teaching and research institution, any type of bike or car rally would cause air and noise pollution as well as traffic jams, resulting in serious inconvenience to the other students and staff as also adversely impact teaching and research activity. Thus, request for car/bike rallies shall not be entertained.
- 3) The directions of the Hon'ble High Court at Allahabad in Writ C No. 16633 of 2019 (AMU Vs. State of UP and Others) have to be strictly adhered and thus no person is allowed to convene, hold, attend, join or address or take part in procession or join any kind of Dharna Pradarshan and rally on the main gate of the Administrative Block of the Aligarh Muslim University, through Bab-e-Syed, University Road up to Maulana Azad Library including the Vice Chancellor's Lodge.  
*Thus, event at any of the locations specified hereinabove cannot be organised without prior permission of the competent authority for which request has to be necessarily submitted at least 48 hours in advance. However, such requests would be considered on a case to case basis and permission may be denied in the interest of maintaining peaceful academic atmosphere.*
- 4) Display on the person or on any vehicle or through any other mode/device of any type of insignia/symbol/indicating affiliation to any political entity/group is strictly prohibited in AMU campus and its maintained institutions. Further, no political party/entity/group shall be permitted to use the land, building, compound, wall etc. of AMU and its maintained institutions for pasting pamphlets, banners, displaying party flags, writing slogans etc. or holding any type of event/meeting etc.

It is hoped that all bonafide students shall appreciate our concern and cooperate in maintaining peaceful academic atmosphere in the campus.

The above orders be strictly adhered to, failing which appropriate action shall be taken as per AMU Students' Conduct and Discipline Rules, 1985.
