

Applications on the prescribed form are invited for the temporary appointment of **Assistant Professor (Contractual)** in Education at **AMU Centre Murshidabad (West Bengal)** on fixed Salary (Initial pay of newly appointed Assistant Professor) against the vacant positions (08). The appointment will be purely temporary till the end of the Academic session 2019-20 or till GSC is held, whichever is earlier and liable to termination at any time without assigning any reason thereof.

QUALIFICATIONS- ESSENTIAL:

A Perspectives in Education of Foundation Courses:

- (j) Postgraduate degree in Social Sciences with minimum 55% marks and
 - (ii) M.Ed. degree from recognized University with minimum 55% marks
- OR
- (iii) Post Graduate (MA) degree in Education with minimum 55% marks and
 - (iv) B.Ed./B.El.Ed. degree with minimum 55% marks

B Curriculum and Pedagogic Courses

- (i) Post Graduate degree in Sciences/Mathematics/Social Sciences/Languages with minimum 55% marks
- (ii) M.Ed. degree from a recognized University with minimum 55% marks

Besides fulfilling the above qualifications, the candidates must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET

Further, the award of Degrees to candidate registered for the M.Phil/Ph.D programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bylaws/Regulations of the Institution awarding the degrees and the Ph.d. candidates shall be exempted from requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:-

- a. Ph.D degree of the candidate awarded in regular mode only;
 - b. Evaluation of the Ph.D thesis by at least two external examiners;
 - c. Candidates have published two research paper from his/her Ph.D work out of which at least one must be in a referred journal;
 - d. The candidate had presented two papers in seminars/conferences from out of his/her Ph.D. work
 - e. Open Ph.D viva voce of the candidate had been conducted;
- (a) to (e) as above are to be certified by the Vice-Chancellor/Pro-Vice-Chancellor/Dean(Academic Affairs)/Dean (Universities instructions).

NOTE: *At present, University is inviting all eligible candidates for interview for the post of Assistant Professor vide O.M. D.No. 1093/SC (T) dated 08.09.2018. If the number of candidates for any vacancy becomes unmanageable in the opinion of the Vice Chancellor, then the University may use short listing criteria as prescribed in the Ordinances. For this purpose, if required, there will be a Committee of Dean, Chairperson of the concerned Department and one Nominee of the Vic Chancellor.*
