

Applications on the prescribed form are invited for the temporary appointment of **Assistant Professor (Contractual)** on fixed Salary (initial pay equal of newly appointed Assistant Professor) against the vacant position (01) in the **Dept. of Library & Information Science**. The appointment will be purely temporary till the end of the Academic session 2019-20 or till GSC is held, whichever is earlier and liable to termination at any time without assigning any reason thereof.

ESSENTIAL QUALIFICATIONS

Eligibility A or B:

(A)

- I. A master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign University.
- II Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil/Ph.D. degree) Regulations, 2018 and their amendments from time to time as the case may be, are exempted from NET/SLET/SET:

Provided, The candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/ Bye-laws/Regulations of the Institution awarding the degree and such Ph.D candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in the University subject to the fulfillment of the following conditions:

- a) The Ph.D. degree of the candidates has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a referred journal;
- e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

The fulfillment of above condition is to be certified by the Registrar/Controller of Examination of the University.

NOTE: NET/SLET/SET shall also not be requirement for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

(B)

The Ph.D. degree has been obtained form a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the times Higher Education (THE) or (iii) the Academic Ranking of world Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

NOTE: *At present, University is inviting all eligible candidates for interview for the post of Assistant Professor vide O.M. D.No. 1093/SC (T) dated 08.09.2018. If the number of candidates for any vacancy become unmanageable in the opinion of the Vice Chancellor, then the University may use short listing criteria as prescribed in the Ordinances. For this purpose, if required, there will be a Committee of Dean, Chairperson of the concerned Department and one Nominee of the Vic Chancellor.*
