Applications on prescribed form are invited for **three (03) Positions of Assistant Professor** in Interdisciplinary Nanotechnology Centre for Academic Session 2019-20 on payment as per University rules. The appointment will be made as Assistant Professor (Contractual) on fixed salary and to be filed as per UGC norms. The appointment will be purely temporary basis liable to termination at any time without any notice or assignment of any reason. **The specializations in which positions are to be filled are Physics/ Chemistry/ Biotechnology. One post is reserved for disabled person.**

Essential Qualifications:

- I. Good academic record as defined by the university with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in a relevant subject from an Indian University, or an equivalent degree from an accredited foreign university **with research experience in the areas of Nanomaterials/Nanotechnology.**
- II. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC like SLET/SET.
- III. Notwithstanding anything contained in sub-clauses (i) and (ii) above, Candidates, who are or standards and procedure for awarded a Ph.D. Degree in **Nanotechnology related areas** accordance with the University Grant Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in University/ Colleges/Institutes.
- IV. NET/SLET/SET shall also not be required for such Masters programmes in disciplines for which NET/SLET/SET is not conducted.


Further, the award of degree to candidates registered for the M.Phil/Ph.D. programme prior to 11 July 2009, shall be governed by the provisions of the then existing Ordinances/By laws/Regulations of the Institutions awarding the degree and the Ph.D. candidates shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutes subject to the fulfilment of the following conditions:-

- a. Ph.D. degree of the candidate awarded in regular mode only;
- b. Evaluation of the Ph.D. thesis by at least two external examiners;
- c. Open Ph.D. viva voce of the candidate had been conducted;
- d. Candidate has published two research papers from/based on his/her Ph.D. work out of which at least one must be in a refereed journal;
- e. Candidate has made at least two presentations in conferences/ seminars, based on his/her Ph.D. work.

(a) to (e) as above are to be certified by the Vice-Chancellor/Pro-Vice-Chancellor /Dean (Academic Affairs)/Dean (University Instruction).
