4. In case the bidder does not turn up within 10 days from the date of finalizing the bid to take the delivery, an amount 2% of the auction value per day shall be charged as ground rent for next 15 days and thereafter the deposited amount shall be forfeited in favour of AMU, Aligarh.
5. **The Auction Committee reserves the right to accept or reject any or all offers/ rescheduled or postpones the auction without assigning any reason.**
6. All the cases of dispute will be subject to Aligarh District Court Jurisdiction.
