## Local Advertisement No.02/2014 dated 02.08.2014 Session, 2014-2015

Applications are invited on prescribed form for appointment against **one** position of **GUEST TEACHER** in Geology in the Department of Geology, Faculty of Science, AMU, Aligarh on payment of an honorarium as per University rules. The appointment will be on temporary basis till the end of the session 2014-2015 and liable to termination at any time without any notice or assignment of reason.

### **ESSENTIAL QUALIFICATIONS:**

- (i) Good academic record as defined by the concerned University with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in the relevant subject from an Indian University, or an equivalent degree from an accredited foreign University.
- (ii) Besides fulfilling the above qualification, candidates must have cleared the National Eligibility Test (NET) conducted by the UGC or CSIR, similar test accredited by the UGC like SLET/SET.
- (iii) Notwithstanding anything contained in sub-clauses (i) and (ii) to this clause 4.4.1, candidates, who are, or have been awarded a Ph.D. degree in accordance with University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions.

### OR

The candidates awarded Ph.D. Degree by the Aligarh Muslim University prior to 11.07.2009, the date of notification of UGC (Minimum Standards and Procedure for award of M.Phil/Ph.D. Degree) Regulation 2009 or admitted prior to the aforesaid date and awarded Ph.D. degree after the above notification shall also be eligible to apply for the post of Assistant Professor/Guest Faculty provided they fulfill minimum 6 out of 11 Criteria recommended by the Thyagrajan Committee and produce a certificate to this effect issued by the office of the Controller of Examinations.

(iv) NET/SLET/SET shall also not be required for such Master's Programmes in Disciplines for which NET/SLET/SET is not conducted.

### Note:

A relaxation of 5% may be provided at the graduate and Master's level for the Scheduled Caste/Scheduled Tribe/Differently-abled (Physically and visually differently-abled) categories for the purpose of eligibility and for assessing good-academic record during direct requirement to teaching positions: The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks without including any grace procedure.

Prescribed application forms may be downloaded from the Website of the Registrar, AMU (www.amuregistrar.com) and submit the same in the Office of the Chairman, Department of Geology, AMU, Aligarh during office hours along with a Cash Receipt of Rs.150/-to be deposited in Cash Section, Finance & Accounts Office, AMU, Aligarh.

Note: i) All the eligible candidates will be interviewed tentatively on August 19, 2014 (Tuesday) at 10.00 A.M. in the Office of the Dean, Faculty of Science, AMU, Aligarh. No separate interview letter(s) will be issued and no T.A. & D.A. will be paid in this regard.

ii) Those who have already applied against advertisement No.01/2014 dated 12.06.2014 need not apply again. They will be considered on the basis of their eligibility for the aforesaid post. However, they will have to give their consent for considering their candidature for Guest Teacher on a fixed honorarium as per rules.

(iii) Further, the advertisement No.01/2014 dated 12.06.2014 may be treated as cancelled.
