Applications on prescribed form are invited for appointment as **Assistant Professor (contractual) in Residential Coaching Academy, AMU, Aligarh** on the terms and conditions as approved by the University for such appointments. The appointment will be purely temporary till March, 2018 and liable for termination at any time without notice or assignment of reason.

### **Essential Qualifications:**

1. Good academic record with at least 55% of the marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in English/Economics/Political Science/Geography/Sociology/Commerce/Law from an Indian University or an equivalent degree from an accredited Foreign University;
  2. Besides fulfilling the above qualifications, candidates must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET;
  3. Notwithstanding anything contained in sub-clauses (i) and (ii) above, candidates, who are or have been awarded a Ph.D. degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. degree) Regulations, 2009 shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions;
  4. Further, the award of Degrees to candidates registered for the M.Phil./Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/By Laws/Regulations of the Institution awarding the degrees and the Ph.D. candidate shall be exempted from requirement of the minimum eligibility condition of NET/SLET/SET requirement and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the conditions:
    - (a) Ph.D. degree of the candidate awarded in regular mode only.
    - (b) Evaluation of the Ph.D. thesis by at least two external examiners.
    - (c) Candidates have published two research papers out of which at least one in the refereed journal from out of his/her Ph.D. work.
    - (d) The candidate had presented two papers in seminars/conferences from out of his/her Ph.D. work.
    - (e) Open Ph.D. Viva-Voce of the candidate had been conducted.
- (a) to (e) as above are to be certified by the Vice Chancellor/Pro Vice Chancellor/Dean (Academic Affairs)/Dean (University Instructions).

**Note:**

1. A relaxation of 5% may be provided from 55% to 50% of the marks at the Master's level for the SC/ST, physically and visually challenged candidates.
2. A relaxation of 5% may be provided from 55% to 50% of the marks to the Ph.D. degree holders who have passed their Master's degree prior to 19.09.1991.
3. Relevant grade which is regarded as equivalent of 55% where the grading system is followed by the recognized University shall also be considered eligible.
4. The eligibility of candidates will be determined as on the last date of submission of employment forms.

Last date for submission of application forms is **13.11.2017**. Working candidates and retired employees are not eligible to apply. Candidates called for interview shall not be paid TA/DA.
